TCAA's services are provided through the following programs:

Adult and Family Services: TCAA operates five programs designed to intervene with an individual or family during a crisis and/or help them move towards greater self-reliance. These programs include:

Community Action Program (CAP): In FY22, a total of 5,642 Tempe households (an estimated 11,284 adult and children) received CAP services including emergency rent/mortgage and utility assistance, crisis case management, and resource navigation assistance during a temporary crisis. TCAA screened households for eligibility and authorized payment of more than \$13,320,000 in public and private funds for overdue rent, utility, or mortgage bills during the fiscal year.

Interfaith Emergency Lodging Program (I-HELP) & Oasis Drop-In Center: The I-HELP shelter program involves a network of faith-based organizations who offer their facilities for safe overnight sleeping spaces for 40 beds on a nightly basis.

Volunteer groups provide the evening meal service, while TCAA's case management team assists enrolled adults with alleviating barriers to entering permanent housing. In FY22, 381 adults were sheltered in the I-Help program, among which, 300 participated in case management services and 39 transitioned to housing. More than 6,130 visits from unsheltered persons were made to the Oasis Drop-In Center, which offers a range of resources for unsheltered individuals such as emergency food, access to mail, phones, and computers, and assistance with recovering lost identification documents.

Health Start: The Health Start program served 1,435 adults and children from across

the East Valley. Services included parenting skills training, nutrition education, access to pre-natal and post-partum medical services, early childhood development screenings, life skills training, and resource navigation, offered by experienced Community Health Workers. During FY22, 113 babies were born to expectant parents, among which, 98% were born with healthy birthweights.

Food Pantry and Garden: TCAA provides access to emergency food boxes at our site as well as through distribution at local schools and home-delivery. In FY22, 15,777 individuals of all ages were served by the Food Pantry including 2,450 first-time customers, while 2,103 students and families received TCAA's food boxes at Tempe/Kyrene School sites. Including repeat visits, a total of 36,387 people were fed by this vital program. More than 19,040 food boxes/bags were distributed by TCAA, containing a total of 621,000 pounds of food-enough to provide 518,113 meals to people in need. Food boxes are supplemented with fresh produce grown in TCAA's Escalante Community Garden.

Financial Success Center: The Financial Success Center serves low to moderate income households and local employers seeking to hire qualified candidates. During the FY22 period, 94 adult participants received employment assistance, income supports, and/or financial coaching from TCAA. The average wage at job placement was \$17.24 per hour. Participants improved their credit scores by an average of 76 points.

Senior Services: TCAA's Senior Independence programming provides the necessary resources and services to enhance the lives of older adults and adults with disabilities and promotes independent living. Services are offered in senior centers as well as in-home service for seniors and adults with disabilities.

Senior Center Lunch Program: TCAA provides nutritious, hot, catered meals to seniors and adults with disabilities at Tempe and Scottsdale Senior Centers. During FY22, 289 older adults and adults with disabilities were served at Tempe and Scottsdale Multi-Generational Centers. TCAA also provides a home-delivered meal service for homebound adults in Tempe and South Scottsdale. During the fiscal year, 459 seniors and adults with disabilities received the HDM service. A total of 76,563 meals and wellness checks were provided during the year.

Neighbors Helping Neighbors: The NHN program assists Tempe seniors-most of whom live alone-with non-medical support services for healthy aging in place. In FY22, 193 Tempe seniors were served in the NHN program. among which, 134 received case management services, 186 received non-medical in-home care (rides, friendly visits, held in the home/yard, or pet care{, and 1,226 case management interactions were completed. TCAA now offers in-home care for Tempe seniors who are struggling to age in place.
